While the above people are recommended by Presbytery, the Session or its equivalent in each Pastoral Charge has the authority to invite anyone whom they determine to be suitable for conducting services for their congregation, on an occasional basis.

Compensation for worship leadership services without additional pastoral responsibility is \$206 plus incidental expenses and travel (.39 per kilometer) based on one service. If there are two or more services, we encourage congregations to add at least \$25 to the minimum remuneration.
